Summary:

Efficiently pick-up and deliver required material to a specified location while maintaining safe work practices. Assist other employees and/or managers in a positive manner when necessary.

Essential Job Functions:

- Drive and operate trucks in safe consistent manner following regulations and policies.
- Follow instructions, directions & schedules from Manager.
- Pre-inspect truck before leaving the truck yard; do post-trip inspection upon return to truck yard.
- Responsible for basic vehicle maintenance; comply with all safe work practices, policies, and processes at all times for example: DOT regulations & Company policies.
- Complete and verify paperwork for accuracy in a timely manner.
- Consistently maintain a safe work environment for themselves and others.
- Have a positive attitude and work well in a team environment.
- Must consistently perform ALL tasks to company standards both safely and efficiently.
- Must be willing to work long hours 8-to-12-hour shifts; 40 hours a week with occasional overtime, 5 days a week with possible weekends.
- All drivers are required to wear Approved fire-retardant (FR) outer garments, hard hat, safety (steel) toed work boots, and eye protection <u>AT-ALL-TIMES</u> when outside of vehicle while on customer's location. If necessary, hearing protection, harnesses, respirators and other appropriate Personal Protective Equipment (PPE) may also be required.
- Ability to utilize various hand/power tools safely and efficiently. These include but are not limited to: hammers, pipe wrenches, end wrenches, hammer wrenches, pipe cutters, threaders, power heads, shovels, rakes, post hole diggers, chain vices, screw drivers, etc.
- Must be able to perform physical activity including but not limited to: shoveling, climbing ladders and stairs, lifting, carrying heavy objects exceeding 50 lbs., support body weight with arms only, running, walking, sitting for extended periods of time, etc.
- Must maintain professional relationship with company personnel and customers at-all-times
- Other duties as assigned.

Qualifications and Education Requirements

- Must maintain a Class A Commercial Driver's License <u>at-all-times</u>.
- Must be able to effectively communicate and understand the English language.
- Have reliable transportation to/from company office or yard.
- Must be able to pass all drug testing as required by company policy (pre-employment, random, post-accident or reasonable suspicion).
- Must complete a physical capability test and maintain physical capability.
- Must maintain a clean Motor Vehicle Record (MVR) and pass criminal background check.
- Obtain Safeland certification and any other required safety courses.
- Ability to find solutions for and/or to deal with day-to-day work-related problems efficiently.
- Ability to complete work-related tasks to required standards even in stressful situations.



- Ability of decipher safe and un-safe working conditions and implement best course of action.
- Ability to communicate effectively with others using written or spoken word.
- Ability to maintain a productive work environment at all times.
- Ability to remain attentive to detail and provide feedback when necessary.
